COVID-19 Service Policy**

My team and I at Nastahja's Hair Bar welcome you back from the quarantine. Although we will not be able to hug you or shake your hand, we are excited to provide you with quality service. During the pandemic, your safety and the team at Nastahja's Hair Bar is important. My team and I put a great deal of thought into creating a safety guideline while reviewing recommendations from the CDC (Center for Disease Control), Governor Charlie Baker and Mayor Martin Walsh.

To alleviate safety concerns my team and I will continue washing our hands, sanitize salon chairs, styling tools, and wash station for each client and wear a mask. The Esthetician and Eyelash technicians will sanitize all tools and stations. Stylists will be 6 feet apart in adherence to social distancing. Please note stylists may wear a face shield at the wash station. In addition, Esthetician and Eyelash technicians may wear a face shield during servicing. The Entrance to the salon such as door and door knobs will be sanitized frequently.

**What is Covid -19?**

Covid – 19 is a respiratory disease caused by a Novel (or new) Corona Virus that has not previously been in humans. Reported illnesses range from mild symptoms to severe illness and death for confirmed Covid – 19 cases. Corona virus spread through respiratory secretion, droplets from cough and sneezes.

**Appointment Reschedule/Cancellation Guidelines**

Please reschedule if you have the following symptoms or diagnosis within 2 to 3 days prior to servicing:

- **Fever**
- **Cough**
- **Shortness of breath**
- **Pneumonia**
- **Tested Positive for Covid-19**

**Client Safety Guidelines**

Client safety requirements is as follow to be serviced:

- **Clients are required to wear a clean mask that covers nose and mouth in a snug manner**
- **Clients are required to wear gloves**
- **Clients who arrive early or if the stylist is occupied with a client prior to the service, is required to wait in the hallway outside the entrance of the salon**
- **Guests and children that are not being serviced will not be allowed in the salon**

**Payment**

It is encouraged that clients use contactless payment whenever possible. Credit card terminals will be sanitized frequently.

**Please Note:** When entering the salon for service there is a risk just as entering any business establishment. My team and I are dedicated to keep you safe, while being serviced.
